

“HOLD HARMLESS” AGREEMENT & LIABILITY RELEASE for DEE’S DOGGIE DEN, LLC.

RESPONSIBILITY & LIABILITY:

I feel confident that Dee’s Doggie Den, LLC (DDD) makes every effort to provide a clean, safe, open environment for all pets that are left in their care. I agree to leave my pet for DAYCARE, BOARDING, or GROOMING AT MY OWN RISK. I have researched the facility and I AGREE with the “Open Play” environment, outside exercise, all DDD policies & procedures. **I understand that ALL dogs/cats CAN & DO BITE;** and I am aware of **(1) the RISK of injury to my pet & (2) that I am responsible for any INJURY, Physical or Financial Damages caused by my pet to another pet, person or DDD facility.** I will NOT hold DDD or employees, responsible should an ACCIDENT, INJURY, ILLNESS, DEATH or LOSS of my pet occur while in their care.

MEDICAL TREATMENT:

In my absence, I give my permission to Dee’s Doggie Den (DDD) to act on my behalf in case of an EMERGENCY or apparent health related issue. I also give permission for my pet to be transported by car to (1) my personal veterinarian, (2) Hillside Vet Clinic, (3) Emergency Animal Clinic for any situation that medical assistance is needed while in the care of DDD. **I agree to reimburse DDD for all charges incurred for any medical care. I WILL NOT seek retribution from DDD should an ACCIDENT, INJURY, ILLNESS, DEATH OR LOSS of my pet occur during or following ANY services rendered by DDD or it’s employees.**

VACCINATIONS/OVERALL HEALTH:

I hereby declare that my pet is current within the calendar year on (1) RABIES (2) DHLPPC/FDLKV (3) Bordetella Vaccinations. I understand it is the policy of DDD to require proof of vaccinations by Vet Records, Verbal Verification, or Current Tags. I also understand that **my pet is still susceptible to other illnesses due to AGE, STRESS, Nutrition Levels, Immune System, and exposure to other dogs.** I understand that DDD prefers all pets be at least **6 months old, Spayed/Neutered, friendly, sociable, and clean with no Fleas/Ticks.** I agree to reimburse or pay for any charges incurred by DDD for my pet to adhere to these policies.

IMPORTANT DETAILS:

- (1) I understand that **DDD is NOT responsible for misplaced, lost, damaged or broken items.**
- (2) I understand the **rates, payment terms, & the hours of operation for DDD.**
- (3) I understand that if I am **NOT satisfied with the services provided by DDD, that I will notify DDD by close of business the following day.**
- (4) I understand that DDD has the **right to refuse service to any pet** that is aggressive, bites, unmanageable, too loud, or NOT suited for the DDD environment.
- (5) I understand that **DDD will NOT release my pet** to anyone without my consent.
